The pre GRLTF era (1/2)The experience of past LIFE programmes in the member states has highlighted the importance of LIFE national contact points. The LIFE national contact point tasks have been assigned to permanent personnel of the Ministry of Environment & Energy, among a series of other duties.







The pre GRLTF era (2/2)

Overwhelming bureaucracy to the beneficiaries from the public sector

Financial crisis

Stakeholders managed to perform in a very difficult financial and administrative environment with very limited support and coordination on behalf of the national authorities

In addition, it enables users to exchange ideas, access information, educational material, finding potential partners, and subscribing to electronic mailing lists.

The Database includes three ways for

searching data about LIFE projects: a) based on project information b) based on project deliverables and c) based on geographic location of the project deliverables.

The Database has already 1.047 unique users with 5.475 visits from 104 countries all over the world.

, The GRLTF era (8/13)

Promotion of best practices and dissemination of results of Greek LIFE Projects

47 LIFE projects were presented in 9 info – days allocated in different cities assisting the participants with ideas of a local character.

17 exchange events where 192 projects promoted their best practices and results to 1.809 participants in total.

42 LIFE projects were presented through the website's

special section 'the month's LIFE project'









, The GRLTF era (9/13)

Financial and technical training on project management of ongoing projects 13 beneficiaries implementing a LIFE project have been supported by the GR LIFE. GRLTF contributed to speed the procedures for the legal adoption of: (a) the Species Action Plans that have been the outcome of 3 LIFE Projects and (b) the Biodiversity Plan and the Management Plan that were the outcome of 2 LIFE Projects.

Enhancement of synergies between LIFE and other funding opportunities

3 meetings have been held between the GRLTF and the management authorities of the Structural Funds programmes in Greece.

Synergies developed with representatives of other networks related to the environment, such as H2020, Interreg, COSME, Creative Europe, Erasmus, EEA grants, BBI-JU and URBACT.

Follow up of the completed Life projects to

<u>enhance their After-LIFE performance</u> The most important problems that After LIFE plans face



in Greece during their implementation are: 1) collaborating bodies do not undertake their respective responsibilities, 2) issues of functionality and jurisdiction responsibilities, 3) securing funds, 4) partnership – consortium setup, 5) issuance of administrative/legal decisions and laws, 6) low capacity building







, The GRLTF era (12/13)

Identification of possible co-financing sources

12 potential co-financers were identified and approached from the beginning of the project

<u>Milestones:</u>

(1) The Board of the Environmental Association of Municipalities of Athens and Pireaus unanimously decided to support its member -

Municipalities when implementing traditional LIFE

projects. This decision led to the establishment of the

first official co-financing source.



(2) The representative of the Maritime Affairs and Insular Policy Ministry in the Blue Fund expressed her will to support mature projects when applying for LIFE through the resources of the Blue Fund.
